### Old Business

- Financial Report

    - MTU Limitations
    - Publish Running Config
  - Recommendations
    - Publish standard config for MICE ports, no member details
    - Publish suggested config for member side
    - MTU Size: MICE will support jumbo frames (Up to 9000 bytes); this is how the IX is set up today
  - IP House, Wikstrom, and Paul Bunyan are the beta testers for implementing these new policies. Information about test dates and discussion will be posted to the list.

### New Business

- IPv6 Numbering Plan
  - Great point, not worth pain of renumbering
- Finances and future needs
  - Google is connecting to the Exchange
    - Not on Google network; live cache
    - Will connect large appliance to exchange
    - Expect MPLS region to outgrow quickly and be on the Google network
    - Shipping device, no timeline yet
    - Asking for /26 and transit
    - In the past, the position of MICE was transit is not the exchanges business (we've assisted with getting that transit in the past); we will maintain this policy with the comment that we can help connect you with people from whom you can obtain those services
  - Content (all content) is pushing to the exchanges paying to let the content come in (general trend)

- Providers are saying they're a benefit to the exchange, so members should pay for everything (transport, rack, power, x-connects, etc.)
  - This is informational for discussion at this time only
